What is the overall deductible? If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your deductible?	Yes. Other than office visits, rehabilitation/habilitation services and durable medical equipment, all other services described in this document are covered before you meet your deductible. Does this plan provide Minimum Essential Coverage? Yes.
